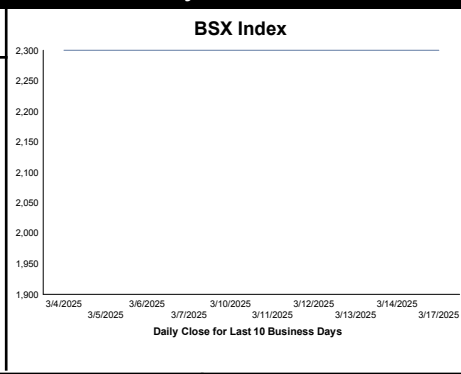

 Yield: Yield is the current dividend or interest a stock or bond will earn, with the yield expressed as a percentage of the amount paid for the security or of the security's par value.
 Mkt Cap: Market Capitalisation is determined by multiplying the number of outstanding shares by the current market price.
