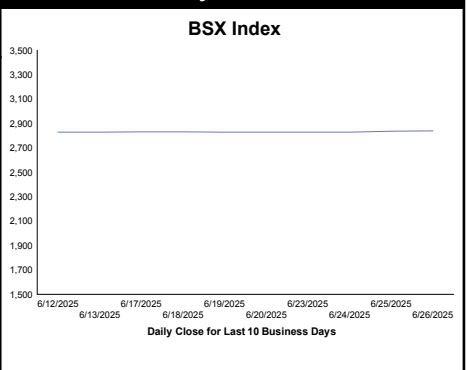

P/E Ratio
 P/E Ratio is calculated by dividing the current market price by the company's 12 month earnings per share (As shown in the latest published accounts).

Price/Book
 Price/Book Ratio is calculated by dividing the current market price by book value per share.

Div Amount
 Dividend is the amount of money distributed to shareholders by a company.

Yield
 Yield is the current dividend or interest a stock or bond will earn, with the yield expressed as a percentage of the amount paid for the security or of the security's par value.

Mkt Cap
 Market Capitalisation is determined by multiplying the number of outstanding shares by the current market price.
